

Use Cases

Compliance for Confluence has been designed with data loss prevention in mind and as a result, addresses a number of important use cases:

- Classifying sensitive data: Automatically label and categorise pages based on their sensitivity.
- Applying access permissions: Restrict access to specific pages for any individual or team.
- **Identifying sensitive information:** Scan Confluence pages within an entire space to identify sensitive data.
- Automated protection actions: Automate actions that can limit access to pages or mark pages as restricted once sensitive data is detected.


With Compliance for Confluence, teams can seamlessly manage and protect sensitive content while ensuring compliance with company policies.
